SETTING UP YOUR ACCOUNT

- The Supplementary Information Document, Key Investor Information Documents, Prospectuses and application forms can be obtained from our website (www.insightinvestment.com) or by speaking to your Insight contact.
- On your application form, please identify the share class(es) in which you wish to invest. You can check this with your contact at Insight Investment.
- The amount may be left blank if you want to open the account and invest at a later date.
- Applications received after 12 noon on any dealing day (as set out in the Prospectus) will be processed on the next dealing day.
- All application forms should be sent, with an authorised signatory list and anti-money laundering documentation in line with the requirements detailed on the appropriate form to:

- You may fax applications to 0131 525 9900, unless you are investing in an ISA or making regular contributions or withdrawals.
- If you have sent your application by fax, you are required to provide original documentation to the same address.
- Failure to provide the original documentation will result in redemption payments being withheld.

METHOD OF PAYMENT

Monies will be required on receipt of a Contract Note and payment can be made electronically to the appropriate account detailed below. Subsequent applications and redemptions can be made by fax or telephone before 12 noon on any dealing day.
